- U7/U11 extra ice time discussion / decision: From the coaches meeting, the consensus was that
  there needs to be more development around skating skills at the younger levels. How can we get
  more hands-on support to develop the players? Adding in another practice for development.
  There is lots of ice available within our association to utilize an extra practice/ ice time designed
  for development. Dustin makes the motion to add an additional practice to U7 every other week
  until Christmas (Thursday's at 5:45- Small Ice) starting in October. Nicole Handziuk seconds the
  motion. All in favour.
