- Operations normal at this time, I have not been made aware of any equipment issues.
- McDonalds Jerseys have been ordered for the 25/26 season. Once again we were able to obtain 4 sets 2 away and 2 home. We typically give one set of the current jerseys to the team, I will be working to communicate which set they will obtain this season.
- In the next couple of weeks I will be setting up dates and process for equipment returns, as equipment returns come in I will balance inventory and communicate any missing items.

Report for AA Director

Sending my regrets for the Meeting on Feb 6, I will be out of town but would like to call into the meeting if possible.

- Attached to this email is the AEHL January Operations update
- Since the season started Hockey Alberta has established multiple working groups pretty much to do with everything AEHL related. AEHL and one of the working groups have rolled out the Programs Standard Overview Draft. I have presented this to the Bisons Committee, and we will be awaiting the final copy as it appears that there will be some work to complete during the off season. I have attached the draft as well.
- Hockey Alberta released in November a satisfactory survey for players to complete. This is attached for your information
- Elite team formation outline has been review with the Bisons as there are some changes for the 25/26 season. It is now up to the associations as to the number of player commitments they can issue. The only stipulation is that there needs to be a honest attempt for a player who works hard over the summer to have a chance in the fall. Okotoks Athletic Association will be releasing once the approve how many commitment they will be issuing for the AAA teams after spring ID Skate. Preliminary conversation are between 15-18 players will be committed per AAA team, but this is not be approved and is just a conversation at this time.
- Hockey Alberta and another working group hosted a couple of meeting with us to discuss the formation of u13AAA for the 25/26 season. They proposed 2 U13AAA Teams for our AAA draw zone which includes Strathmore, Chestermere, Okotoks, Foothills. And to for next season at least reduce the u13AA teams from 3 to 2. The Bisons committee countered this proposal along with Strathmore saying 2 u13AAA teams would water down the program in the first year and to



phase this in with 1 team starting next season. Hockey Alberta and the working group chose to stand behind their proposal and for the 25/26 season there will be 2 U13AAA teams. One will be hosted in Okotoks and the other in Strathmore. They also have recommended that Okotoks U13AA for the 25/26 season send all players to the Bisons U13AA program. Bisons and OOAA need to meet and set out the parameters on this. We feel that this will make our AA program stronger and support this proposal. Lots of work on this ahead of us.

- Couple minor bumps over the last month, can talk more about it in the meeting as we had one concern noted with an official.

Development Report February 6, 2025

-going to start trying to get some feedback from coaches on what's working and what's not.

-need to discuss what we are doing for evaluations next season. If we are hiring out might need to lock that in sooner than later.

-goalie development. Need to take a good look on attracting goalies and developing them. We are running low in that department. Maybe we need to look at reducing fees for goalies. How can we help develop them as well.

-need to have a meeting with Intro league and discuss future plans. Especially regarding U9. Doesn't make a lot of sense to have a couple U9 A teams that go around destroying the B teams. Lots of complaints around this. Maybe A teams need to be put into CAHL. Need input. Vulcan is going to write a letter regarding getting full Ice sooner to Hockey Alberta as we run our own Intro League. I think we need to support even if it's a long shot to actually happen.

-once we get some feedback look at changing up development plans for next season. Have a couple ideas based on feedback especially around Intro.
