- There is a surrounding association with a policy in place that if a player is placed on a team and then that said player leaves. The association will suspend said player for a season.
- Steve would like to propose and adopt the same procedure that OMHA has with regards to suspending players that leave when they do not like the team that they are placed (look at OMHA's evaluation policy- it is attached below. FMHA will word the policy to fit FMHA wording) Bryce seconds the motion. 1 abstain. 10 in favour. Motion carried.

If a registered player leaves the association during or after 2 evaluation skates to move on to another minor hockey association or to a private league to play the season, the following will occur.

- 1. Suspension from registering with OMHA for the next season:
 - The player who leaves under the specified circumstances will be suspended from registering with Okotoks Minor Hockey Association for the following season.
- 2. Inability to participate in tryouts:
 - The suspended player will not be allowed to participate in tryouts for the following season, further limiting their options.
- 3. Limitation on trying out for outside associations (OOAA):
 - The policy also aims to restrict players from trying out for OOAA (elite branch of OMHA) because
 they cannot register under the governing body of OMHA.
- 4. Exception for players trying out for OOAA and leaving the association in the same year without OMHA tryouts/evaluations:
 - An exception is mentioned for players who try out for OOAA, get released, and leave the
 association in the same year without participating in OMHA tryouts or evaluations. In this case,
 they can register again for the following year.
- This policy is intended for players leaving OMHA to play elsewhere. It does not include players who just decide not to play the current season and does not include player who are injured before, during or after the evaluation process. (See Injury Policy)
 - The purpose of this policy is to protect other members who stay and play in OMHA. Decisions are
 made in every division based on the numbers we have registered. By players leaving during the
 process or after selection it affects all players and teams in that division.

It's essential for players, parents, and stakeholders to carefully review and understand the implications of this policy. If there are any specific questions or concerns, it's advisable to contact the Okotoks Minor Hockey Association directly for clarification and additional information.

MISCELLANEOUS:

- Sock Invoices will be sent out this week. Intro to Hockey Managers Handbook states that socks
 will be \$20.00 a pair, actual cost is \$22.05 this year. We will have to eat the cost of \$2.05 for the
 U9 teams. I request that the cost of socks be removed from any manuals/regulations as the
 price can change year to year and we don't receive the invoice till after Managers have received
 the handbooks.
- With the instability of Canada Post, can I get approval to use my personal credit card to renew TeamSnap this year and be reimbursed from the association?
- The website under Coach, it states that only 5 staff can be carded, \$25.00 will be charged over and above that. The actual cost LAST YEAR for a carded Minor Coach is \$61.60 (HA and HC), an Intro Coach is \$53.71. This will be going up for this season; we just won't know the cost for sure till January. I suggest we look at this for next year and charge accordingly otherwise we are not covering our costs.
